It is our distinct honor to present the Goodwin Foundation 2023 Annual Report. On behalf of the Goodwin Foundation board and the Goodwin University trustees, thank you for your sustained support of the University and for the life-changing impact you have made on our students.

As you read about the accomplishments celebrated in this annual report, we hope you will take pride in all we have made possible together, with your help. Some highlights from this year include:

- Thanks in part to a transformational two-million-dollar gift from the George W. Bauer Family Foundation, the Harrison Steans Advanced Manufacturing Center at University of Bridgeport was opened. Staffed by Goodwin University faculty, the center will initially offer classes at the college level in Welding, with plans for a Computer Numerical Control (CNC) lab underway.
- This year, through the generosity of our donors, the Foundation awarded \$445,595 in scholarship funds to 184 students. This funding was due in part to the great success of our two signature fundraising events. The ninth Annual Clambake raised over \$28,000, and the 18th Annual Golf Tournament raised a record \$114,000 to support hard-working Goodwin students.
- We were fortunate to create two new scholarship funds: the Evan Howard Scholarship Fund and the Excellence in Nursing in Memory of Mary Galatro Donahue RN Scholarship. We are honored to carry on the memory of these two exceptional people who will continue to have a positive impact on the lives of our students.

The impact of your investment in the Goodwin Foundation is beyond measure, and we thank you wholeheartedly for changing the lives of hundreds of students who will in turn make huge contributions to our state's economy and our community.

As Goodwin University enters its 25th Anniversary year, we are proud of our partnership with YOU. ## Events

The Goodwin Foundation held its two signature events in 2023 to raise funds for student scholarships. The 9th Annual Summer Clambake was held on Goodwin's campus overlooking the Connecticut River on June 15, and featured University of Bridgeport's Steel Drum Band, clambake fare catered by Flander's Fish Market, entertainment by Adam Rivers from iHeart Radio, and beverages donated by Square Peg Pizza, Putnam Plaza Super Liquors, and Coca-Cola. A silent auction raised over \$12,000 and featured many unique items and experiences, including a rocket stove handcrafted by Goodwin's Welding program and Adirondack chairs built by students from Connecticut River Academy, Goodwin's magnet high school.

The Goodwin Foundation 18th Annual Golf Tournament was held at the premiere private Hartford Golf Club on August 7 and included a full day of golf, food and beverages, on-course contests, raffles, and auctions.

Together, these events raised over \$150,000 for the scholarship fund in support of Goodwin's hard-working students.



Goodwin offers 43 degree and certificate programs to students across three schools: the School of Applied Liberal Arts and Social Sciences, the School of Business, Technology, and Advanced Manufacturing, and the School of Nursing and Health Professions.

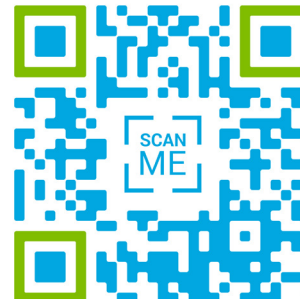

## 2023 ACCOMPLISHMENTS

### George and Carol Bauer — A Legacy of Giving Back

Goodwin University hosted a ribbon-cutting ceremony on October 25 for the opening of the Harrison Steans Advanced Manufacturing Center on University of Bridgeport's campus. The event drew a crowd from both Universities, along with local and state officials, who gathered to celebrate and learn more about this hub for advanced manufacturing education.

The center opened to its first cohort of welding students, taught by Goodwin University faculty, in the fall of 2023, to help fulfill a critical need by providing hands-on training in a field where Connecticut depends on a skilled workforce. Among the distinguished guests were representatives of U.S. Senators Chris Murphy and Richard Blumenthal, who helped secure Congressionally Directed Funding for the center's programming.

George and Carol Bauer provided a generous two-million-dollar gift to Goodwin University to name the center after Mr. Bauer's dear friend and colleague, Harrison Steans. Together, the two men supported educational programs for high school students, providing a college education for those who graduated. Mr. Bauer noted that they encountered a common obstacle

in this work: some successful high school graduates didn't want to attend a traditional college, but chose to work with their minds and their hands instead. "When I saw Goodwin's manufacturing facilities, I told myself, 'They broke the code. This is what we've been dreaming of,'" shared Mr. Bauer at the ribbon cutting. "Harrison would be so pleased with what you've done here."

CBIA president Chris DiPentima, a graduate of University of Bridgeport's school of law, remarked, "[This project is] the most important workforce-related project happening in our state today. This is not the manufacturing center — this is the manufacturing epicenter. This is a huge opportunity to really propel our state."

At the ribbon cutting, Chief Manufacturing Officer for the State of Connecticut, Paul Lavoie, noted that while Connecticut is the 48th-smallest state in the country, it "sits among giants in manufacturing."

"There is no better time in our state's history to make sure we are doubling down on a well-skilled and well-trained workforce to support our 368 manufacturing companies," he added.

## FIP Construction

FIP Construction has been a longstanding and invaluable partner of Goodwin University. Their support began during Goodwin's early years, and their impact can be seen throughout the River Campus. FIP began work by developing our main building, transforming the old oil tank farms into the beautiful campus seen today.

Their efforts are evident throughout seven of our buildings and 413,000 square feet of development. FIP has made our University's progress possible by working within federal and state grant constraints and making the most of precious financial resources. Placing importance on value engineering each project to get the most out of our investment, they have constructed our flagship building, Health Sciences building, and both magnet schools. FIP's efforts will continue with the upcoming development of our new Magnet Technical High School currently under contract.

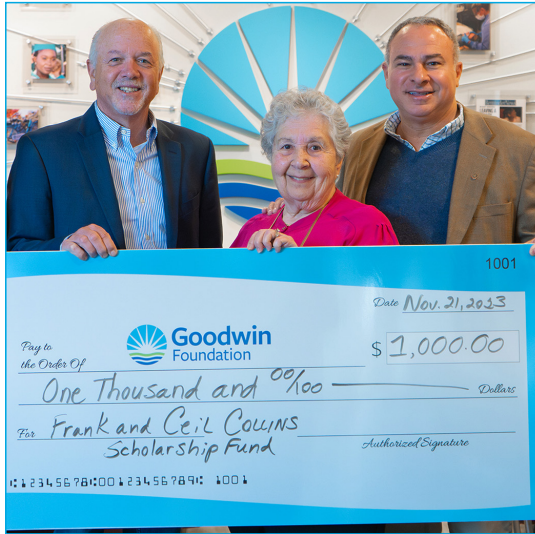
In addition to FIP's construction contributions, they have also been consistent donors. In 2022, they entered into a five-year gift agreement in the amount of \$250,000.

These funds will be equally distributed between the Foundation Scholarship Fund and Frontline Scholarship Fund to help support Goodwin students achieve their educational and occupational goals.

On December 4, a donor reception and naming event was held to celebrate FIP Construction and their generous contributions to Goodwin. President Mark Scheinberg and Foundation Board Chair Ethan Foxman began the evening with remarks on how vital FIP has been in the growth and success of our University. Bill Hardy and Dan Burns from FIP also spoke of the wonderful history between FIP and Goodwin over the years.

The evening continued with the FIP River Room ribbon cutting along with lively reminiscing of many years in partnership together and wonderful custom-made cookies with the FIP Construction logo. We are immensely grateful to FIP for being enduring supporters of Goodwin's vision and helping to implement our plans for progress over the years.

## Excellence in Nursing in Memory of Mary Galatro Donahue RN Scholarship

A new nursing scholarship fund was created in 2023 by a loving daughter in memory of her mother, a devoted and caring nurse who lived a courageous life. Mary Galatro Donahue graduated from Saint Francis Hospital School of Nursing, began her career in maternity nursing, and then dedicated three decades to care of the elderly at Corbin Convalescent, then Brittany Farms Health Center, in New Britain. There, she touched the lives of so many serving as a unit nurse, nursing supervisor, nursing educator, quality control nurse, and ultimately Assistant Director of Nursing. Ahead of her time, she promoted a patient-centric approach that always put her patients first and was truly a role model for others. Near the end of her life, Mary was cared for by Goodwin Nursing students fulfilling their clinical placements and was impressed by their skilled care and compassion, leading to the establishment of this scholarship.

## The Ann B. Clark Co-op

The Ann B. Clark Co-op serves the Goodwin University community and is managed by a team of staff and students. Our strategic work with such partners as Connecticut Foodshare, ShopRite, Stop & Shop, Dairy Farmers of America, and Highland Park Market, as well as generous donations from our supporters, ensures that our shelves are always stocked with quality products. Through the passion, generosity, and inspiration of Goodwin University's provost emerita, Ann B. The laptop loaner program enables students to check out a laptop for the duration of the semester in which they are enrolled. For working adults with families, the ability to take remote classes and access computers around the clock is often the only way they can pursue their education. This program ensures that students have access to required technology to be successful in their chosen programs.



## Mental Health Counseling Services

Normalizing that we all have struggles that get in the way of our progress at times, Goodwin offers mental health and counselling services both in person and virtually, to accommodate personal preferences and ensure student confidentiality. Particularly since the pandemic, we see that students have increased need for a safe place to talk through personal struggles and challenges to help them persist in their education.
