# Application for Admission Occupational Therapy Assistant (OTA)

All pre-requisites must be completed. Developmental courses cannot be transferred from other institutions. All requested documentation must accompany this application. Acceptable documentation is indicated for each pre-requisite. Student acceptance is based on the top 20 applicants who meet admission criteria (see the OTA admission criteria point system in the academic catalog).

Complete the University placement evaluations. Applicants must qualify for a minimum of ENG 101 and MATH 125 in order to enter the Occupational Therapy Assistant program. Any foundational courses required as indicated by the test results must be completed before entering the program. All prerequisite and general education requirements must be completed prior to beginning the program.	Copy of college transcript. Students must submit an official transcript for their record for transfer evaluation.
GPA of 2.7 or greater in college. College GPA is based on a minimum of 12 college credits.	Copy of high school or college transcript. Upon acceptance, students must submit an official transcript for their record within the first 15 weeks.
Completion of the following prerequisite courses with a minimum grade of a "C+" or better:  BIO 211 and BIO 212 (Goodwin University) or equivalent with a laboratory completed within the last five years is the prerequisite for OTA 101.	Copy of high school or college transcript. Upon acceptance, students must submit an official transcript for their record within the first 15 weeks.
Interview with the Occupational Therapy Assistant program director. To be scheduled after application deadline.	Copy of college transcript. Upon acceptance, students must submit an official transcript for their record within the first 15 weeks.
