

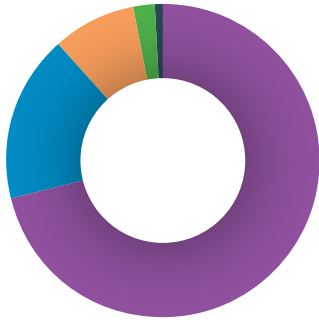

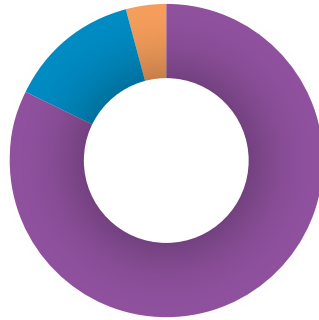

By Source**



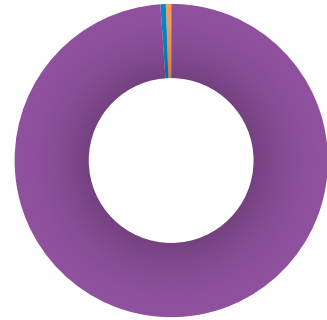
