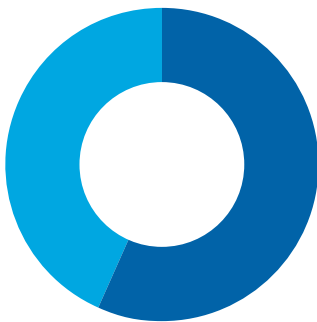




## Foundation Fundraising

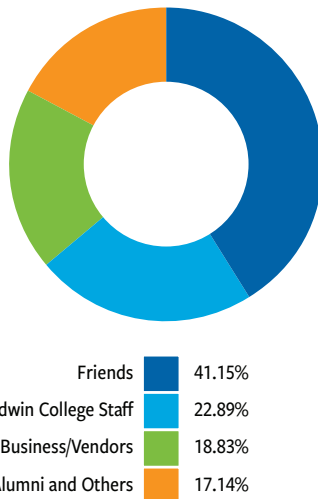

**Foundation Raised (Gross)**



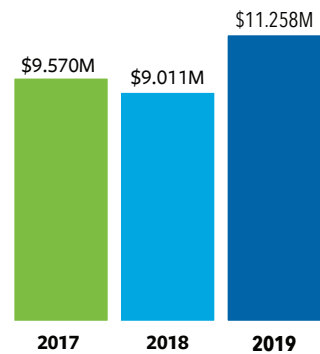

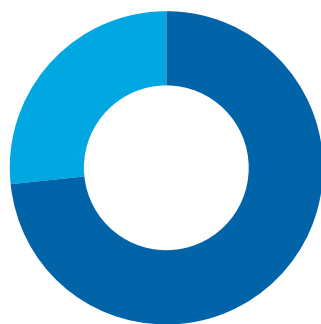


## Scholarships

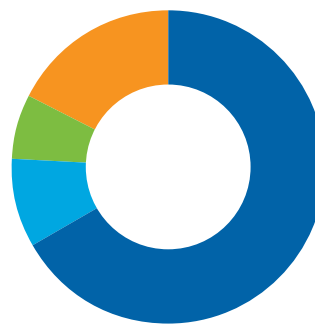
During the 2019 year, 87 scholarships were awarded with over \$224,000 awarded to students.
