Application for Admission **Funeral Service**

For admission into the program, all prerequisite, general education, and non-major core classes must be completed or in-progress at the time of application. This is an entry requirement. If courses are in progress, acceptance will be conditional upon submission of an official transcript immediately upon completion. Developmental courses cannot be transferred from other institutions. All requested documentation must accompany this application. Acceptable documentation is indicated for each prerequisite.

All students must successfully pass a background check and drug screen before official acceptance into the Funeral Service program will be granted. Forms are provided by program personnel Student acceptance is based on the top 20 applicants who meet admission criteria (see the FNS admission criteria point system in the academic catalog).

Complete the College Placement Evaluations. Applicants must qualify for a minimum of ENG 101 and MATH 125 in order to enter the Funeral Service program. Any foundational courses required as indicated by the test results must be completed before entering the Program. All prerequisite and general education requirements must be completed prior to acceptance.	Copy of college transcript. Students must submit an official transcript for their record for transfer evaluation.
GPA of 2.7 or greater in high school or college. College GPA is based on a minimum of 12 college credits.	Copy of college transcript. Upon acceptance, students must submit an official transcript for their record within the first 15 weeks.

Completion of the following prerequisite courses with a minimum grade of "C+" or better: BIO 235 (Goodwin University) or equivalent with a laboratory completed within the last five years.
