On May 24, 2021, Goodwin University celebrated the completion of its acquisition of the University of Bridgeport (UB). This unique relationship allows us to expand our mission at Goodwin to educate a diverse student population in a dynamic environment that aligns education, commerce, and community throughout the state. We would like to assure our donors that contributions to Goodwin University are used exclusively for scholarships and other purposes identified by the Goodwin administration and overseen by the Goodwin Advancement Office. UB maintains a separate Advancement team that directs its own fundraising campaigns, outreach, and events.

"We're all in this together" is very fitting for Goodwin. More than a year and a half into the global COVID pandemic, we still witness our community members guiding one another through these trying times and the resulting after-effects.

For many students at Goodwin, this is their last stop before entering their professional careers. - The Student Affairs Department provides resources outside the classroom like accessibility, career services, student engagement activities, and counseling.

- The Ann B. Clark Community Co-op provides any student or family with food insecurity the necessary food to live a healthy life.







Foundation Fundraising


