

# POLICY AND PROCEDURE

TITLE: Immunization Policy	
----------------------------	--

#### **POLICY STATEMENT:**

The purpose of this policy is to establish university-wide requirements regarding immunizations for students. All students must meet the requirements as established by this policy.

#### **PROCEDURE DETAILS:**

Each student attending Goodwin University (the "University") whether fully online, in a hybrid format or on-ground must have up-to-date and adequate immunizations as required by law. Exemptions from this policy are detailed in the *Exemptions* section of this policy.

As required by Connecticut state law, the following immunizations are required:

For all students born after December 31, 1956: Measles, 2 doses Rubella, 2 doses Mumps, 2 doses

For all students born on or after January 1, 1980: Varicella, 2 doses

For all students that live on campus: Meningococcal, 1 dose within the past 5 years

Each student must provide proof of immunization records to the office of the registrar as part of the application process. Proof of immunization must include documentation from a medical provider's office showing the dates of immunization for each required immunization as stated above. Alternatively, you may use the immunization form in the appendix of this policy, and have it signed by a medical physician or advanced practice registered nurse ("APRN") verifying the information.

If you are requesting exemption from these requirements, per the *Exemptions* section of this policy, you will need to fill out the *Immunizations Exemption Form* which is included in the appendix section of this policy.

#### **EXEMPTIONS:**

A student will be exempt from providing proof of immunization if the student:

- a. Can provide documentation from a medical physician or APRN that such immunization is medically contraindicated;
- b. Can present a statement indicating that such immunizations are contrary to the student's religious beliefs;
- c. Can provide medical documentation from a medical physician, APRN or the director of health of the student's current or former town of residence indicating that the student had a confirmed case of the respective disease;
- d. Is enrolled in an exclusively online program in which the student and the student's classmates do not meet on any campus premises for any purpose. Any student exempt under this provision agrees never to come onto campus for any purpose without the express written permission of the University. Any violation by the student of this prohibition will subject the student to discipline under the University's student code of conduct; or
- e. Graduated from a public or nonpublic high school in Connecticut in 1999 or later and was not exempt by law from the measles, rubella, and, on and after August 1, 2010, the mumps vaccination requirement.

Students who would like to claim exemption from providing proof of immunization are required to submit the *Immunizations Exemption Form* during the Admissions' Application process.

Students may also choose to have a titer test done if they believe they are immune to measles, rubella, mumps and varicella and are unable to access the medical records indicated under option (c). Students will need to provide medical documentation of a titer test. If the titer test comes back either negative or equivocal, the student will be required to provide proof of the required vaccine.

Students that have filed for an exemption to this policy will not be allowed on campus in the event of an outbreak for the duration of the outbreak for a disease that the student is not immunized for as required by law and indicated in the students' records.

If a student is exposed to a disease for which the student is not immunized as required by law and indicated in the student's records, the student must notify the University and will not be allowed on campus until it has been determined that it is medically safe for the student and the University Community.

Please note that even when a student is exempt from the University's immunization requirement, certain programs may require vaccinations for a student to be eligible to work in the field. If this is the case, a student will not be eligible for an exemption under any circumstances and the student may also be required to have additional vaccinations.
